Legal, Financial, Compliance and Related Information

Western Fuels Colorado, A Limited Liability Company (WFC) is renewing Permit No. C-81-008. WFC's New Horizon 1 & 2 Mine is the old Peabody Coal Company Nucla & Nucla East Mine which operated under the same permit. This old Peabody Nucla mine area (the New Horizon 1 mine area) is undergoing final reclamation. Bond was released on 215.5 acres of the New Horizon 1 mine area in the Spring of 2002. WFC assumes that bonding responsibility on the remaining 98.62 acres of NH1 land until such time as bond is released.

This application is intended to apply only to the New Horizon 2 (formerly Nucla East) mine area. Descriptions of environmental baseline data, mining and reclamation plans contained in this application are limited to the New Horizon 2 mine area. The New Horizon 1 area is not addressed in this ~~renewal~~ application. It is undergoing reclamation and there will be no further disturbances at New Horizon 1. There will be minor activity at the New Horizon 1 area to meet bond release requirements (general caretaking activities), but no mining or other disturbances. No New Horizon 2 activity will affect New Horizon 1. All CC ditch activities are located at New Horizon 2. Therefore the New Horizon 1 area is not addressed in this permit renewal. Reclamation commitments for the New Horizon 1 area are contained in a separate document entitled Reclamation Plan.

The statements below are intended to address the requirements of Section 2.03 of the regulations of the Office of Mined Land Reclamation Board for Coal Mining.

2.03.5 Compliance Information

Neither the applicant nor a subsidiary or affiliate or persons controlled by or under common control with the applicant has (a) had a Federal or State mining permit suspended or revoked in the last five years; or (b) forfeited a mining bond or similar security deposited in lieu of bond. The applicant received a notice of violation, dated 14 Aug. 2002, for an unauthorized variation in sec 4.08.3 Public Notification of Blasting Schedule of the Colorado Mined Land Reclamation Board Regulations. For the purpose of determining the ½ mile radius from blasting for neighbor notification, the applicant used the centerpoint of the blasting area, as described in the Blast Schedule published as a Public Notice. The CDMG believes that using the blast area perimeter is more appropriate, hence the notice of violation. WFC has subsequently modified its procedures to use the blast perimeter for determining the notification radius.

2.03.6 Right of Entry and Operation Information

2.03.6(1) Attachment 3-11 of the New Horizon 1 Mine Reclamation Permit presents information concerning the lease agreements or property deeds to mine coal and rights-of-way agreements to enter the mine area. This information describes the legal rights under which Peabody, the previous owner, was permitted to enter and begin surface mining activities. They further specifically identify the type and date of execution, specific lands to which each document pertains, and explain the legal rights held by Peabody.

Attachment 2.03.6-1 at the end of this section presents information where Peabody transferred its rights to all the lease agreements, property deeds to mine coal and rights-of-way agreements to Western Fuels-Colorado, A Limited Liability Company. None of the rights acquired under any of these documents is the subject of pending litigation. This Attachment also includes documents evidencing WFC's right to mine the additional lands.

2.03.7 Relationship to Areas Designated Unsuitable for Mining

2.03.7(1) Unsuitable Designation Status. A determination was made under the criteria set forth in Section 7.05 that no lands be designated unsuitable for mining at the New Horizon Mine. Furthermore, the Office of Mined Land Reclamation, in the "The Nucla Mine (C-008-81) Proposed Decision and Findings of Compliance", January 1983, found that "no Alluvial Valley Floors ~~exsited~~existed in either the mine area or the potentially affected area associated with New Horizon Mine."

WFC is unaware of the availability of any information which indicates that any portion of the New Horizon Mine property has been or is under consideration or study for designation as land unsuitable for mining.

2.03.7(2) Legal and Financial Commitments. WFC has a contractual obligation to supply coal from the New Horizon 2 Mine to the Nucla Power Generating Station owned by Tri-State Generation & Transmission Cooperative.

2.03.7(3) Ownership Waivers. There are five occupied dwellings within 300 feet of the actual mining disturbance from 1993 to the present located within the New Horizon 2 permit area. There are no occupied dwellings within 300 feet of the projected mining disturbance from the present to end of the renewed permit period (~~m~~May 26, 2008). Copies of waivers from the owners of these dwellings consenting to mining operations are included as Attachment 2.03.7-1.

2.03.8 Permit Term Information
