## **OBSERVATIONS**

This inspection was conducted as part of the normal monitoring program established by the Colorado Division of Reclamation, Mining and Safety (Division). The Brandstadt Rock Pit is located approximately 4 miles east of Delta, Colorado off of G Road. The site is a 3.5 acre 110c operation that has intermittent status.

The mine was inactive during the inspection. Material excavating and process material was observed in the permit area.

It appears that the minimal setback of the high wall from the boundary along the southern border of the permit will require some backfilling to accomplish the required 3H:1V final slope configuration.

In an effort to ensure that the financial warranty remains adequate to reclaim the site per the requirements of the approved reclamation plan, DRMS has updated the reclamation cost estimate (sent under separate cover). Therefore pursuant to Sections 34-32.5-117(4) of the Colorado Land Reclamation Act, adequate financial warranty must be submitted to the DRMS within 60 days of the mailing date of this report. Once the estimate is received please review the figures as soon as possible and contact our office if any calculation errors are noted.
