OBSERVATIONS

This inspection was conducted as part of the normal monitoring program established by the Colorado Division of Reclamation, Mining and Safety (Division). The Reynolds Pit is located approximately 3 miles west of Delta, Colorado off of Townsend Road. The site is a 34.01 acre 112c operation. Eldon Reynolds accompanied the inspector during the inspection.

The mine was inactive during the inspection. Evidence of mining was observed in the northern portion of the permit area. The depth of excavation during the inspection was approximately 4-5 feet in depth and the area of disturbance was significantly less than the approved maximum disturbance limit of 18 acres.

A tamarisk infestation was observed within the affected area. The infestation, if not controlled, will most likely hinder and/or delay successful reclamation of this site and contribute to off-site spreading and establishment of tamarisk. The approved weed control plan is either not being implemented or is not effective in its current application. Please indicate what measures will be taken to improve weed control and, if appropriate, submit a technical revision to incorporate these measures into the permit no later than May 4, 2012. Weed infestation is not noted as a problem at this time due to the operator verbally committing to immediately initiating weed control during the inspection. However, if significant progress toward control of on-site weeds is not demonstrated, enforcement action will be initiated.

In an effort to ensure that the financial warranty remains adequate to reclaim the site per the requirements of the approved reclamation plan, DRMS will update the reclamation cost estimate (to be sent under separate cover). Therefore pursuant to Sections 34-32.5-117(4) of the Colorado Land Reclamation Act, adequate financial warranty must be submitted to the DRMS within 60 days of the mailing date of the reclamation cost update. Once the estimate is received please review the figures as soon as possible and contact our office if any calculation errors are noted.
