The Division of Reclamation, Mining and Safety (Division) has completed it's of your April 20, 2012 response to our preliminary adequacy review of your 112 construction materials reclamation permit conversion application. The initial application was received on January 13, 2013. Preliminary incomplete information was address and the application was called complete for review on February 17, 2012. The decision date for this application is May 17, 2012. Please be advised that if you are unable to satisfactorily address any concerns identified in this review before the decision date, **it will be your responsibility to request an extension of the review period.** If there are outstanding issues that have not been adequately addressed prior to the end of the review period, and no extension has been requested, the Division will deny this application.

The review consisted of comparing the aforementioned preliminary adequacy review letter you're your response letter, dated April 20, 2012. Any inadequacies are identified under the respective exhibit heading along with suggested actions to correct them.

6.4.1 EXHIBIT A - Legal Description

1. The legal description on Exhibit A in the conversion application does not match that in the new Exhibits C-1 and F-1 for the "Stockpile Site". Please submit a revised Exhibit A with both the Mine Site and Stockpile Site legal descriptions. The "Mining Pit" label should be changed to "Mine Site" and the "Stockpiling & Processing Area" label should be corrected to "Stockpile Site". The legal description for the "Stockpile Site" should match the corrected descriptions on Exhibits C-1 and F-1 submitted to the Division on April 20, 2012.

Please remember that the decision date for this application is May 17, 2012. As previously mentioned if you are unable to provide satisfactory responses to any inadequacies prior to this date, **it will be your responsibility to request an extension of time to allow for continued review of this application.** If there are still unresolved issues when the decision date arrives and no extension has been requested, the application will be denied.
