OBSERVATIONS

This inspection was conducted as part of the normal program established by the Colorado Division of Reclamation, Mining and Safety. The Triantos Pit is located southwest of Delta, Colorado off of Sundown Road. The site is a 112c-phased operation. Larry Record of Delta County accompanied the inspector during the inspection.

The mine identification signs are in place and in compliance with rule 3.1.12. The signs are located on a post at the main entrance at both mine locations. The permit boundaries are comprised of white PVC posts that are easily identifiable around the entire perimeter of the mine.

The pit is currently active. Adequate amounts of topsoil and overburden appeared to be stockpiled for the approved reclamation plan. Stockpiles of processed material were present during the inspection in both mining locations.

No onsite or offsite stormwater erosion was observed during the inspection.

No problems or possible violations were observed during the inspection.
