The reclamation of the Deepe Farm Sand and Gravel Pit (Permit No. M-1998-036) has been completed. The purpose of this letter is to serve as written notice to the Colorado Division of Reclamation, Mining and Safety (the Division) of completion of reclamation and to request the release of any related reclamation surety and release of all reclamation responsibilities at the Deepe Farm Pit.
