**Re:** Interim Operating Guidelines for Phase 1 LVSCS

Soon after Phase 1 LVSCS Pump and Transducer #1 was replaced on June 19, 2012, it was concluded that Transducer #2 was not functional, providing a false reading (indicating a high level even when the pump was cavitating).

A work order has been entered to replace Phase 1 LVSCS Pump and Transducer #2. Until this work order is completed, please apply the following operating parameters for Phase 1 LVSCS:

**Pump #1** will be set in the "auto" mode, to be turned "on" at 0.75 Feet and turned "off" at 0.25 Feet.

**Pump #2** will be set in the "manual" or "Hand" mode, with the pump running continuously.

Tim Cazier, Lead Specialist with Colorado Department of Reclamation and Mine Safety ("DRMS"), a.k.a. our "State Inspector", has been notified by telephone on June 20, 2012, of this interim change.

Once the replacement of Phase 1 LVSCS Pump and Transducer # 2 has been accomplished, both pumps will be set in "Auto" at levels that will be determined at that time. A revised operating procedures bulletin for Phase 1 LVSCS will be posted soon thereafter.
