Dear Michael,

Pursuant to your letter of April 17, 2012 concerning the presence of noxious weeds on site, please note the attached "Weed Control Policy" that has been in effect for a number of years. As you know, we have used certain local herbicide applicators to assist us in controlling our weed problem. We try to assess the situation every spring and plan on the appropriate control method for the summer and fall months.

We have recently cleared our site of noxious weeds by severing them below the soil surface and we have initiated a program of spraying the rosettes to prevent seed dispersal.

ARKINS PARK STONE WEED CONTROL POLICY

This weed control policy is to coordinate the preventative measures for noxious weeds. The primary objective of this policy is to prevent the take over of noxious weeds, especially knapweed.

RESPONSIBILITIES

Management will make annual periodic checks of the area to monitor the status of noxious weeds. Management will also be responsible for deciding what methods shall be used to eradicate the problem.

METHODS OF CONTAINMENT

In the spring, management will do a check of the areas and decide which method shall be used first to keep the noxious weeds contained. The main concern is to prevent the knapweed from flowering and going to seed.

Methods that may be used to contain knapweed are:

- Seeding with selected perennial grasses with a recommended seed mix is to be used when there are bare spots.
- The physical pulling of the knapweed including severing the root below the soil surface and placing them in an approved container to lessen the number of knapweed plants.
- Spraying of herbicidse will also be used to decrease the numbers of plants but shall either be used during the spring or fall rosette stage.
- Other biological, mechanical, and chemical controls that may be effective in removing and preventing any infestation.

We have consulted with and will continue to use the services of the Larimer County Weed District for contract spraying using recommended herbicides and application methods.
