CAUSE INFORMATION: The Golden Cross Aggregate Mine (or Golden Cross Aggregates) was reported by people working at the mine, to have dug down to the aquifer. The point at which the aquifer was exposed is 100 ft. from the Platte River. Caller's well is one football field downhill from this point. Caller is also concerned because he thinks the hillside is falling into the pit of the mine. Caller has also spoken with Mike Bender (ph: 303-866-3587), with the Division of Water Resources, who referred him to us. I was unable to reach him. I contacted DRMS, and Tom Kaldenbach (303-866-3567 & 8128) from their office is copied on the distribution for this report. The caller would appreciate a call from a state authority to discuss his concerns.
