Dear Mr. Whinery,

The Division received the more recent NOI materials you sent, which clarified and scaled-back your proposed prospecting plans. The submitted materials listed these changes: the portal would not be reopened, no activity would occur underground, the boulders on top of the dump would not be moved to create an operations pad, no topsoil exists on the site and no revegetation will be undertaken during reclamation, no road or trail improvement will be made, and a generator will be the only piece of equipment to be brought to the site.

Your plan is to access the site by non-motorized means and to prospect for metal values in the existing waste rock on the dump, by using hand tools. There will be no structure brought or built on the site. The reclamation costs associated with this activity will be minimal.

Review of the plan shows that there are no insufficient items in the NOI that remain to be addressed. The Division has therefore approved the NOI, effective on November 29, 2012. A bond amount has been estimated, based on this updated prospecting plan and its attendant reclamation. The bond amount required for this NOI has been set at \$1,069. Please see the attached reclamation cost summary, and notify me promptly if you see any errors or omissions. I am required to inform you that the bond must be received by the Division within 60 days of this letter or the Notice may be denied.

The submittal of a bond (aka financial warranty) will require that certain forms are provided. These are available on the Division's website: www.mining.state.co.us. Click on "Forms Policies & Guidelines" then select "Mineral Exploration and Prospecting Forms." From that page, choose the type of bond instrument you want, as listed under "Mineral Prospecting Financial Warranty Forms (Hard Rock)". Note: Do not choose any bond with "Exploration" in its title. Completed bond forms must be sent to Ms. Coria at the Division's Denver office (see address in letterhead).
