RE: Gold Eagle Mining Company, Burros Mine Permit M-1977-297, Hawkeye Mine Permit M-1978-311,
and the Ellison Mine Permit M-1978-342, Notice of Request for Temporary Cessation Status

This letter is to inform Counties and Municipalities within two miles of a mining operation of the intent of Cotter Corporation to put the above referenced mining operations into a state of temporary cessation (TC). This letter is sent pursuant to the requirement of Rule 1.13.6 (1) of the Rules and Regulations of the Colorado Mined Land Reclamation Board.

Please be advised that on March 1, 2013 Gold Eagle Mining Company whose address is P.O. Box 3007, Montrose, Colorado 81402 filed a Notice of Temporary Cessation with the Division of Reclamation, Mining and Safety for the permitted JD-5 mining operation. The mining operations are located Township 44 N, Range 18 W, and in Sections 30 and 32 in Western San Miguel County.

The first period of temporary cessation will commence on January 4, 2013 and will last up to five years from that date until January 4, 2018. The notice submitted to the Division contains information pertaining to the reasons for cessation of the mining operation, a plan for resumption, and the measures taken to comply with reclamation and other necessary activities related to the performance standards of Rule 3 of the Rules and Regulations in order to maintain the mine in a non-producing or non-development state.

The Notice of Temporary Cessation will be placed on the monthly agenda of the April 17-18, 2013 meeting of the Mined Land Reclamation Board. During that meeting, the Board may consider acceptance of the notice so long as there are no issues with performance or reclamation standards via inspection, file review, and no concerns are expressed by interested persons who would be adversely affected or aggrieved.

Please submit written comments regarding the matter to the Division by no later than 5:00 PM, April 16, 2013.
