COMMENTS

This was a complete inspection of the Sunlight Mine conducted by Brock Bowles and Carla DeMasters of the Colorado Division of Reclamation, Mining and Safety. The permit for this mine was revoked and the bond was forfeited. The reclamation was completed by the Division. Weather conditions were sunny and warm. The perimeter of the permit boundary was mapped with a Trimble GeoXT GPS unit. This information will be used to verify existing maps and as a basis for a vegetation monitoring plan. There were many atv tracks noted on the lower portal area.

BACKFILL and GRADING - Rule 4.14

Contemporaneous Reclamation 4.14.1; Approximate Original Contour 4.14.2; Highwall Elimination 4.14.1(2)(f); Steep Slopes 4.14.2, 4.27; Handling of Acid and Toxic Materials 4.14.3; Stabilization of Rills and Gullies 4.14.6:

The backfilled portal area did not have signs of slumping or cracking (photo 1). The soil above the lower fan portal is collapsing. The hole did not seem bigger than it was during a previous inspection last September 2012.

FISH and WILDLIFE – Rule 4.18:

Scratch marks were observed in the bark of an aspen tree on the lower portal area. It appeared that an animal with sharp claws climbed the tree (photo 2).

The upper section of the clean water diversion ditch on the upper portal area was free and clear of obstructions (photo 3). The clean water diversion ditch culvert going under the county road on the western side of the mine site was almost completely obstructed (photo 4).

REVEGETATION – Rule 4.15 □ Vegetative Cover; Timing:

The vegetation is starting to green-up on the lower and upper portal areas. Some early season grasses and forbs were noted but the trees have not started to break their buds. An alder tree had recently been uprooted and placed by the water flume in the lower portal area.


SIGNS AND MARKERS - Rule 4.02:
