### SCOPING NOTICE

#### RIMROCK J-BIRD MINE PLAN OF OPERATIONS AMENDMENT

The Bureau of Land Management, Uncompahgre Field Office (BLM), is seeking input regarding a mining proposal by Rimrock Exploration and Development, Inc. (Rimrock) to add exploration drilling and access to an existing, authorized uranium and vanadium mining operation. The location of this mining operation is in Sections 13, 14, 23, and 24, Township 47 North, Range 20 West, New Mexico Principal Meridian, on Wray Mesa in western Montrose County, approximately 4.5 miles southwest of Paradox, Colorado.

Rimrock has submitted a mining plan of operations (POO) amendment to the BLM.

The amendment proposes to add up to twenty (30 feet by 30 feet) exploration drill sites per year or up to a total of 200 drill holes, and up to 4,000 linear feet of drill access roads if necessary, over a 10 year lifespan to their existing and authorized POO. Rimrock would use existing and previously disturbed exploration drill access roads to the extent possible. The proposed amendment would add no more than an additional maximum total of 5 acres of new surface disturbance from both drill site areas and the drill access area to their existing 4 acres of surface disturbance. Concurrent reclamation would greatly reduce the amount of un-reclaimed surface disturbance from the drilling operation present in any period of time. The plan amendment does not identify specifically where drill sites or road improvement or construction will occur in the project area, but would allow for such use somewhere in the project area.

The BLM has determined that this proposed action must be evaluated under the National Environmental Policy Act (NEPA) to evaluate the potential impacts to human health and the environment. The BLM is seeking any comments you may have related to this project. Your comments will assist in identifying issues that should be addressed as part of the analysis being prepared for this project. If you are interested in participating in the environmental analysis process, or have specific concerns, issues, or alternatives that you would like addressed, please provide written comments to:

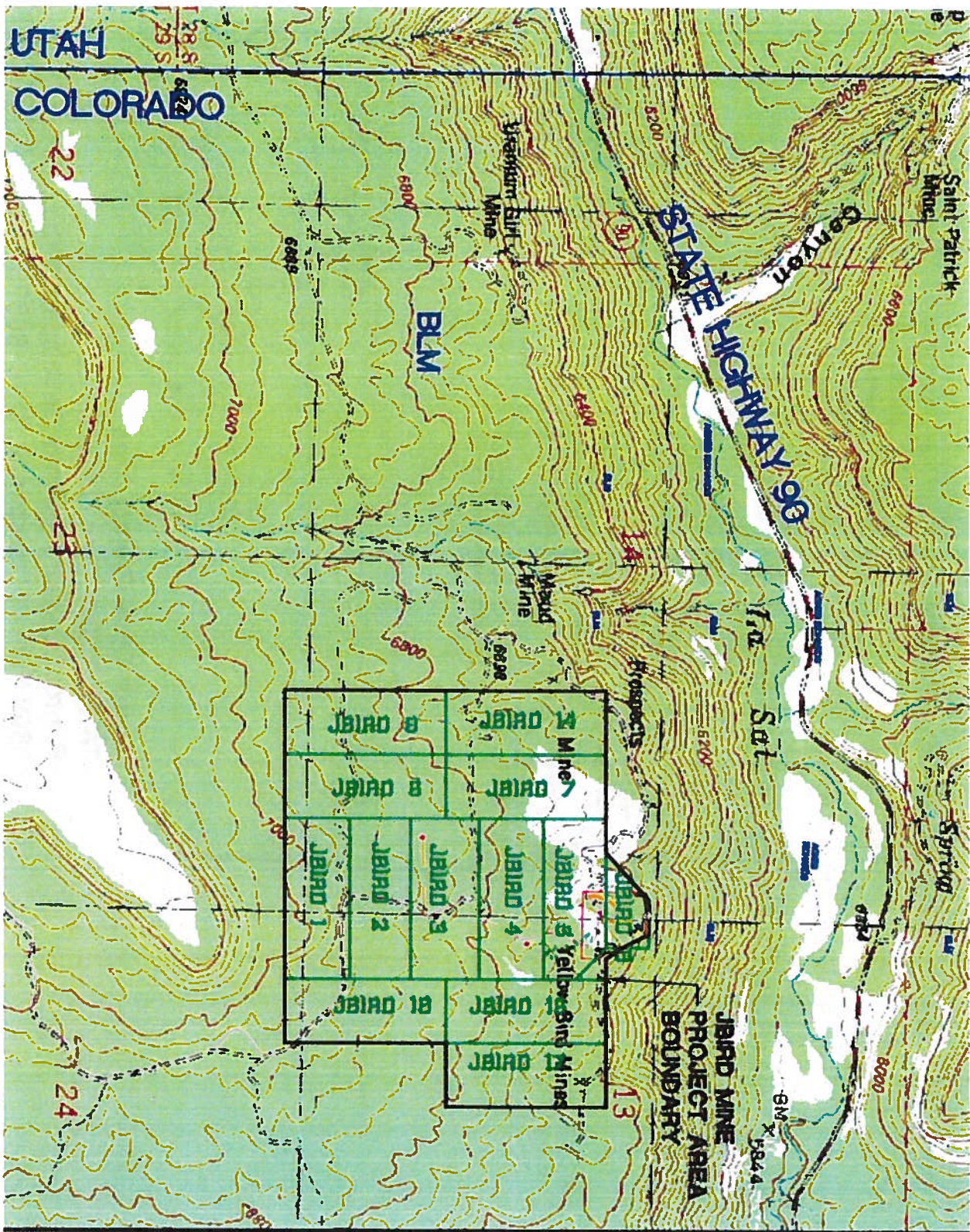

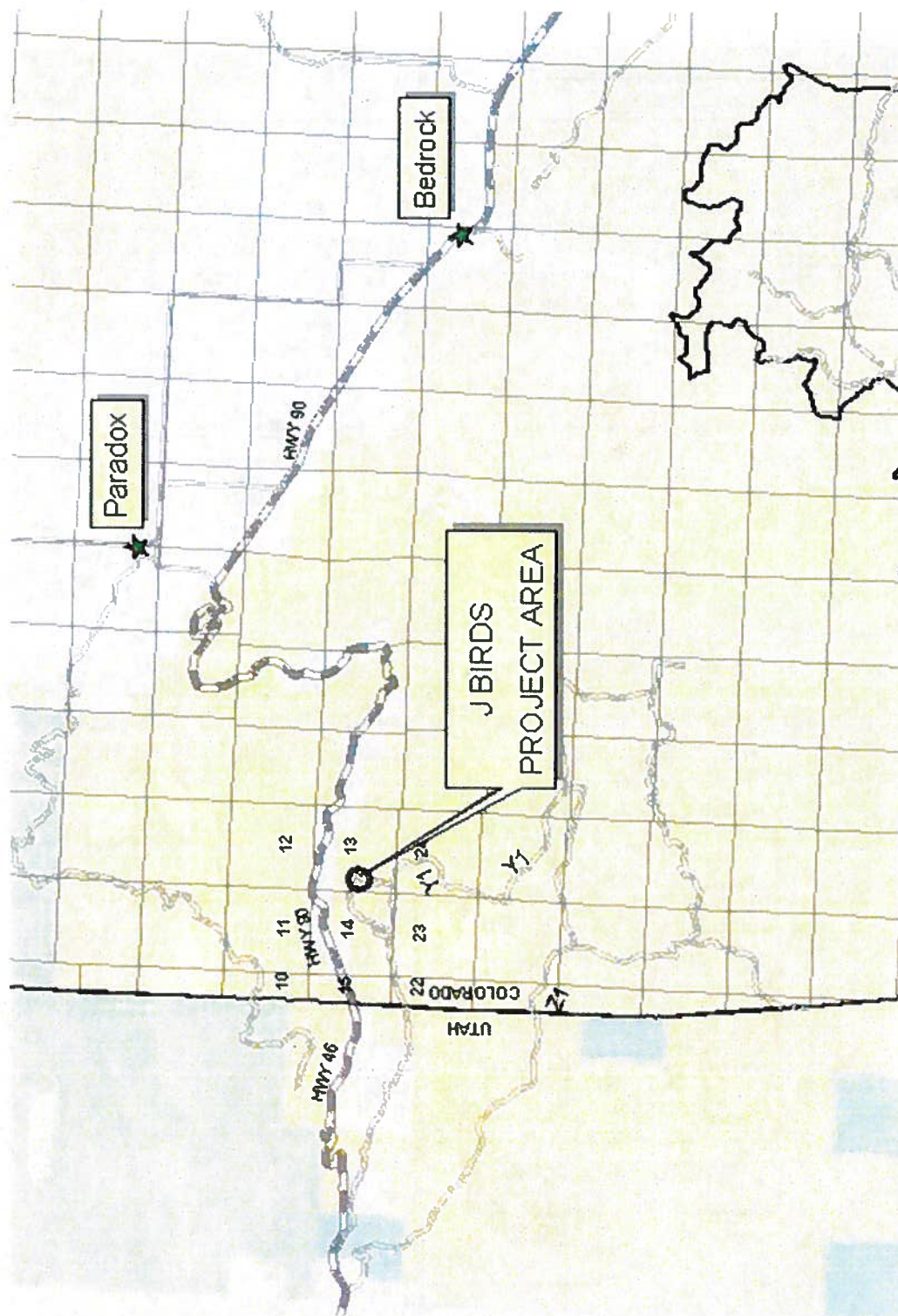
