Dear Mr. Luttrell and Mr. Lewicki:

On or about April 12, 2013, the Division received an application to amend the above referenced 112c application. Pursuant to Construction Materials Rule 1.4.1(8) the Division has conducted a preliminary review of the application materials and has determined the amended application to be incomplete for the purposes of filing. Pursuant to Rules 1.1(20.1) and 1.4.2, the following items must be received before the Division can consider your application as being filed and commence the technical review.

## Filing Deficiencies for the Amended 112c Application

- 1. Please complete all portions of the application form. Specifically, please check the box at the top of page 1, clarifying there is a file number already assigned to this operation.
- 2. Please complete all portions of the application form. On the form for the amended application the Applicant failed to initial items 1 through 10, located on pages 5 and 6.
- 3. Pursuant to Rule 1.4.1(3), all information submitted in an application must be accurate and complete, and acknowledged as such by the signature of an authorized agent on an application form provided by the Board. The signature page of the application, page 8, is critical, especially the portion completed by the notary. The notary must authenticate the signature of the authorized agent for the Applicant. The Applicant must be identified on the application form <u>exactly</u> the same as registered with the Office of the Secretary of State. As noted on the enclosed certificate provided by the Office of the Secretary of State the correct name of the Applicant is "Rocky Mountain Aggregate &

Loretta E. Piñeda Director Construction, LLC". However, on page 8 of the amended application form the Applicant is represented as Rocky Mountain Aggregate & Construction. The error in name of the Applicant was repeated by the notary. Please ensure the correct name of the Applicant, "Rocky Mountain Aggregate & Construction, LLC", is displayed on page 8 of the application form and especially for the portion completed by the notary.

- 4. Please correct the error on Exhibit A, Legal Description, indicating the permit area at 247.76 acres. The error appears in the first paragraph of page A-1.
- 5. Pursuant to Rule 1.6.2(1)(c), the above items must be placed with the application materials at the County Clerk and Recorder's Office. Therefore, please submit an updated Exhibit I, Proof of Filing with County Clerk, in accordance with Rule 6.3.9 and correcting the filing deficiencies identified within this correspondence.

Pursuant to Rule 1.4.1(8) the Applicant has 60 days from the date of this correspondence to submit all of the necessary documents required for filing. If, at the end of the 60-day period the application has not been determined to be filed with the Division the application may be denied and the file may be terminated. Please satisfy the above listed filing deficiencies within 60 days, by June 17, 2013.
