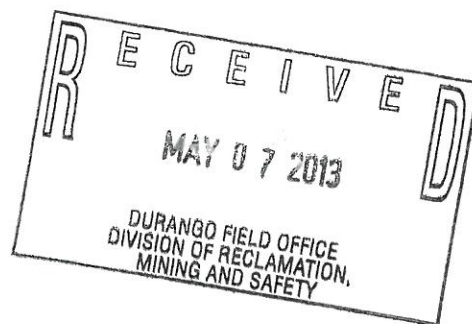

RIO GRANDE SILVER, Inc.; PO Box 610, Creede, Colorado 81130 Ph. # 719-658-1080, has filed an Amendment to an Existing Regular (112) Hard Rock/Metal Mining Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Mined Land Reclamation Act. The purpose of the Amendment is to add to the land package for the mine operation. The proposed mine is known as the BULLDOG MINE, and is located at or near section 35 and 36, Township 41 and 42 North, Range 1 West, 10th (New Mexico) Prime Meridian.

The proposed date of commencement is August, 2013, and the proposed date of completion is August, 2033. The proposed future use of the land is Wildlife Habitat.
