In a previous notice from the Division of Reclamation, Mining and Safety (Division), dated April 30, 2013, you were informed of an amendment being filed to the above referenced application and the resulting extension of the Division's review process for the application. The Division has received written objections to the application. Therefore, pursuant to Rules 1.4.9(2)(a) and 1.7.4(2), the Division has scheduled the application for a Formal Board Hearing for consideration. The hearing has been rescheduled for the August 14-15, 2013 Board meeting, which will occur at 1313 Sherman Street, Room 318, Denver, Colorado, beginning at 9:00 a.m. or as soon thereafter as the matter can be considered. During the hearing the Board will consider the application with objections and may decide to approve, approve with conditions, or deny the application for the Uncompany Pit.

Pursuant to Rule 2.7.1, the Division has scheduled a Pre-hearing Conference to occur on <u>July 25,</u> <u>2013</u>, in the Centennial Room at 433 South First Street, Montrose, Colorado, beginning at 1:00 p.m. and terminating at or before 3:00 p.m. For those commenting parties who received the notice from the Division, dated April 30, 2013, please note the previous date of the Pre-hearing Conference, August 1, 2013, has been vacated and the Pre-hearing Conference has been

The Pre-hearing Conference will be held to describe the Division's review process, to explain the rights and responsibilities of parties, to discuss and resolve issues to the extent possible, to describe the Board Hearing processes, to propose a list of issues under the Board's jurisdiction, to simplify that list, and to identify parties.
