The proposed mine is known as the New Hay Camp Pit, and is located at or near Sections 14 and 23, Township 37 North, Range 15 West, 10th P.M. The proposed date of commencement is August 31st, 2013, and the proposed date of completion is August 31st, 2025. The proposed future use of the land is rangeland. 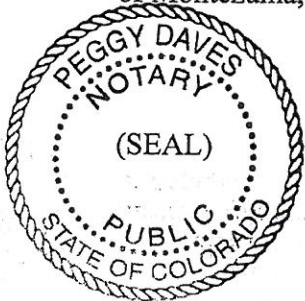
