OBSERVATIONS


This inspection was conducted in response to an application for Temporary Cessation for the site. A sign is posted at the entrance. Roads into the site are stable and well maintained. All affected slopes appear to be stable. The slope adjacent to the main highway along the portion of the access road with the concrete barriers is showing signs of erosion. It does not appear, however, that this slope has been affected by the mining operation and this erosion appears to be a natural feature. Stockpiles on the pit floor appear to be stable and pose no risk of producing sediments that will be carried off site. Berms are installed along the road edge that is upslope from the drainage below.

The site appears to be stable and poses no risk of damage during the period of temporary cessation. See enclosed documents related to temporary cessation.
