Reference: M-1990-025 Hay Camp Pit Reclamation Release, 1 April 2013

Dear Ms. Pickford:

As requested during the site inspection of 5 July 2013, this letter is a revision of the original request for reclamation release as of May 2013, complete or in part (that is, partial surety release), for the affected lands as shown on the attached map, which replaces the map showing affected lands as of May 2012 (the revised attachment to the 2012 annual report).

As of May 2013, and as modified based on your instructions on 5 July 2013, the attached map shows:

Total permit area	460 acres
Total affected area (per latest amendment)	294.1 acres
Areas already released prior to 2012 (shown in blue)	87.7 acres
Areas requesting full release (3 areas shown in green)	21.9 acres
Areas requesting partial surety release (2 areas shown in cyan) Areas with final grade, soil placed, seeded, but with weeds and poor g	60.9 acres grass condition

Area requesting partial surety release (1 area shown in magenta)17.3 acresAreas with final grade, soil placed, but not seeded: also has weed issues and minor erosion

The total area for which full release is requested is 21.9 acres, down from 51.6 acres in the April letter. The areas for which partial surety release is requested: that is, areas with final grade and soils but not vegetated and with weed or minor erosion issues, is 78.2 acres, up from 11.4 acres. While we understand this will not impact the McStone Aggregates reclamation surety, or a County surety (which is not required), but is important for the landowner and both McStone and the County, to clearly identify these areas.

Please note that the north cyan area includes 15.2 areas which was NOT disturbed except by cutting of the pinyon-juniper forest, but which is included in this because of weeds and poor grass. Based on your guidance, I am NOT including that in the request for full release.

For the information of all concerned:

Areas currently affected (used for operations) (shown in red)33.2 acres(The major area of 30.3 acres includes both the McStone and County operations; a small area of 2.9acres along the roads and scalehouse, includes soil stockpiles.)

Areas currently planned for future disturbance (shown in black)	73.0 acres
(Located to the west of current operations)	

Areas not to be disturbed (shown in white (no hatching))165.9 acres

This letter and map are being sent to the Montezuma County Road Department, and LMN Properties, the landowner. Montezuma County intends to have me submit a permit amendment application in the near future to extend the permit and affected lands boundary approximately 3/4 mile to the west, and to address the issue of the southern boundary.
