### ORDER GRANTING REQUESTS TO PARTICIPATE BY TELEPHONE

#### IN THE MATTER OF THE 112c PERMIT APPLICATION OF ROCKY MOUNTAIN AGGREGATE & CONSTRUCTION, LLC, File No. M-2013-007

THIS MATTER came before the Mined Land Reclamation Board ("Board") on August 6, 2013 to consider motions and requests to participate by telephone in the August 14-15, 2013 hearing on the application of Rocky Mountain Aggregate & Construction, LLC ("Applicant") for the Uncompany Pit, File No. M-2013-007. Assistant Attorney General Julie M. Murphy and First Assistant Attorney General Jeff Fugate appeared on behalf of the Division of Reclamation, Mining and Safety ("Division"). There were no appearances on behalf of the Applicant, the objectors, or the supporters.

The Board, being fully informed of the facts in the matter, enters the following:

#### FINDINGS OF FACT

1. On February 26, 2013, the Applicant filed an application with the Division for a 112c reclamation permit for a site known as the Uncompany Pit in Montrose County, Colorado ("Application"). An amendment to the Application was filed with the Division on April 22, 2013.

2. During the public comment periods for the Application and the amendment to the Application, the Division received letters of objection, letters of support, and letters of comment from government agencies.

3. On July 25, 2013, the Board, through prehearing conference officer Steven G. Renner and pursuant to Rule 2.7 of the Mineral Rules and Regulations of the Board for the Extraction of Construction Materials ("Rules"), conducted a prehearing conference in Montrose, Colorado. The Applicant, several objectors, and supporters appeared at the prehearing conference. At the prehearing conference, the prehearing conference officer notified the participants that, in accordance with Rule 2.6(1), any motions and requests to participate in the hearing by telephone must be filed with the Board by 5:00 p.m. on July 29, 2013. 4. On July 26 and 29, 2013, the Board received written requests and motions to participate by telephone from the following parties:

5. On July 30, 2013, the Board received a written request to participate by telephone from parties Keith and Sharon Rasmussen, 20828 Solitude Road, Montrose, CO 81403. The request from Keith and Sharon Rasmussen, dated July 25, 2013, was sent timely to an incorrect e-mail address; Keith and Sharon Rasmussen resubmitted the request to the proper e-mail address.

#### CONCLUSIONS OF LAW

6. The Board has jurisdiction over the Applicant and this matter pursuant to the Colorado Land Reclamation Act for the Extraction of Construction Materials, Article 32.5 of Title 34, C.R.S. ("Act").

7. Under Rule 2.6(1), motions must be received by the Board within two working days following the prehearing conference. In this matter, motions and requests were due to be filed within two working days of July 25, 2013, on or before July 29, 2013. The requests to participate in the hearing by telephone filed by the parties listed in paragraph 4 above are timely under Rule 2.6(1). The request to participate in the hearing by telephone filed by Keith and Sharon Rasmussen is technically untimely under Rule 2.6(1). Considering the reason it was untimely, however, the Board deems the request by Keith and Sharon Rasmussen to be timely. As of the August 6, 2013 Board meeting, the Board received no response to any of the motions and requests.

8. The Act, other Colorado statutes, and the Rules do not expressly confer a right to appear or testify by telephone in this proceeding.

Rocky Mountain Aggregates & Construction, LLC Uncompany Pit/M-2013-007 9. The Board generally does not favor telephone participation. In the Board's experience, presentation of telephone testimony may compromise the integrity and effective management of administrative proceedings.

#### ORDER

Based on the foregoing findings of fact and conclusions of law, the Board conditionally GRANTS the requests to participate by telephone in the August 14-15, 2013 hearing filed by Al and Vicki Becker, Barbara Bernhardt, Stan and Kathy Borinski, Keith and Sharon Rasmussen, Leigh Robertson, Mary Scuderi, and Lester and Kathleen Stigall (the "telephone participants"). The conditions for participation by telephone in the August 14-15, 2013 hearing are as follows:

- A. due to equipment limitations and for effective management of the hearing, the Board strongly prefers and encourages all telephone participants to be in one physical location;
- B. only one telephone participant at a time shall speak during the hearing;
- C. each telephone participant shall identify himself or herself before each time he or she speaks;
- D. only the telephone participants approved in this Order shall be permitted to appear or testify by telephone;
- E. the time restrictions and other provisions set forth in the Prehearing Order, as approved by the Board, will be strictly enforced; the telephone participants must determine among themselves how to allot the available time.
