## NATURE OF ISSUE:

On October 1, 2012 Cotter Corporation (Operator) submitted an amendment application (AM-1) for the JD-7 Pit, in order to incorporate an Environmental Protection Plan into their permit. The application was deemed complete for the purposes of filing on October 26, 2012. The Division received a timely objection to AM-1 from the Information Network for Responsible Mining (INFORM). There are outstanding adequacy review issues and it is unlikely that they can be addressed within the 365 day limit imposed by Rule 1.4.1 (9). The Operator and the Division agree that additional time is needed in order to adequately address the outstanding issues. The Operator has requested to extend the decision due date until January 8, 2014. The Division believes that this will allow adequate time for the Operator to address the outstanding issues, for the Division to review any new materials submitted by the Operator, and to comply with the public participation process requirements.

### STAFF RECOMMENDATION:

The Division recommends the Board approve extending the review period to January 8, 2014.
