OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. Photographs are included with this report in order to illustrate some of the conditions observed.

The Independence Pass site is located approximately twelve miles east of Aspen and accessed from Hwy 82. The site is a 110c operation that includes a total of 5.6 permitted acres. Pursuant to Rule 4.1.2 (2), a financial warranty is not required for this site.

Adequate mine identification signage was noted at the entrance to the site.

The pit floor is the only area not currently reclaimed. The area is used for highway maintenance materials stockpiles and equipment storage. The slopes around the pit have been regraded and vegetated. Noxious or problematic weeds were not observed on site. The east part of the permit area was occupied by an outfitting company. All structures related to the outfitting business appeared to be temporary in nature.

No problems or violations were noted during this inspection.
