Summary of Water Court Application

Application for Surface Water Right.

Staff Recommendation

Staff recommends that the Board ratify the filing of a Statement of Opposition filed on behalf of the Board in June 2025 to protect CWCB's instream flow water rights.

CWCB Instream Flow Water Rights

Potential for Injury

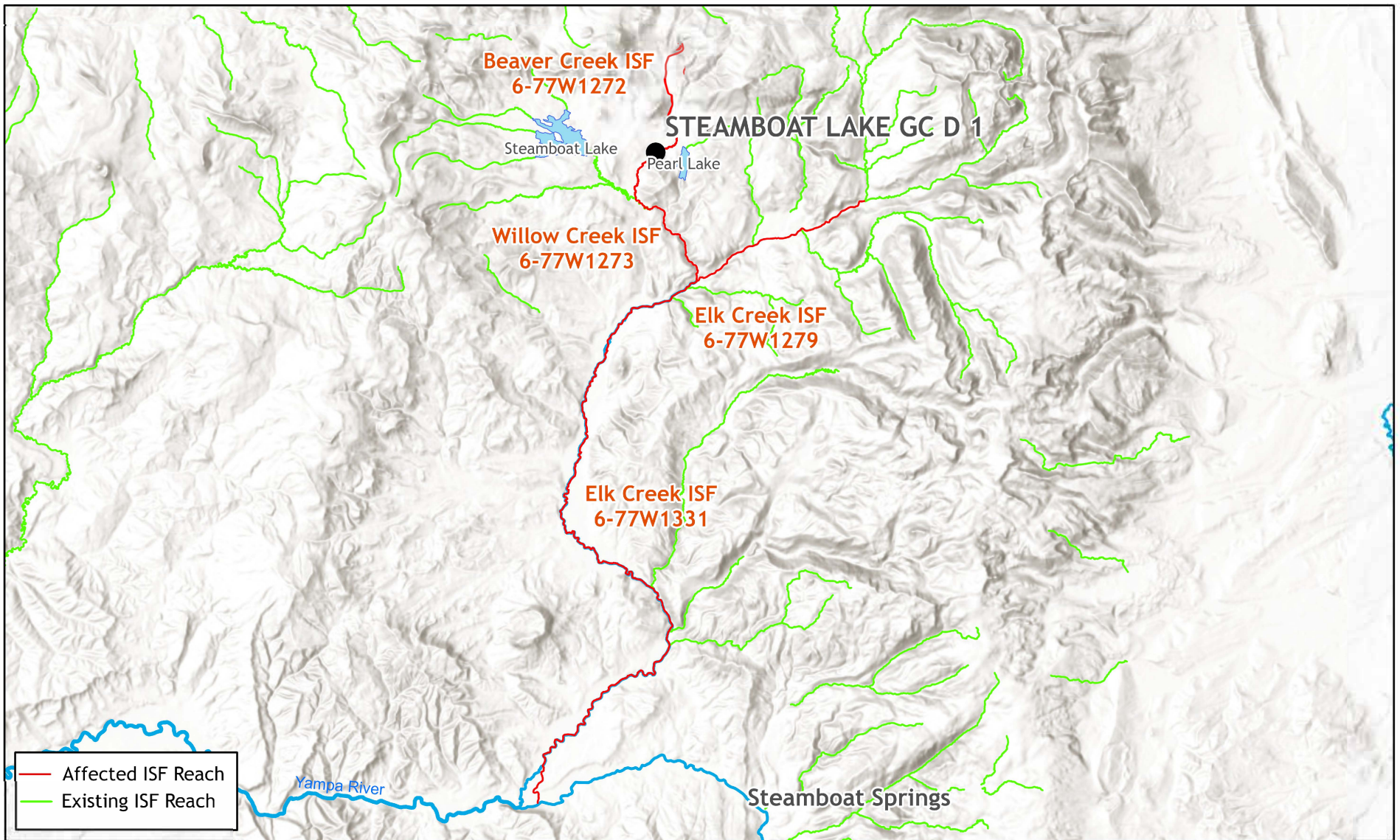
- The proposed flow through water right could injure the CWCB's instream flow water right because it is fully depletive to a segment of the intervening instream flow (ISF), and the consumption from the flow-through diversion could injure the CWCB's downstream ISF water rights.
- Applicant claims some water rights with appropriation dates prior to the appropriation dates of the CWCB ISF water rights. The CWCB's ISF water rights may be subject to the beneficial uses in existence on the date of such ISF appropriations under section 37-92-102(3)(b), C.R.S., so long as the uses are sufficiently demonstrated and documented.
- Terms and conditions should be included in the decree to ensure that Applicants' operations will not injure the CWCB's instream flow water rights.

Statements of Opposition were also filed by Lee Emery & Elaine Emery and S.A.B.L.E. Development Limited Liability Company.
