# **Welcome**

The meeting was called to order at 3:00 p.m. by Vice-Chairperson Austin Keiser.

# **Roll Call/Introductions**

After roll call a quorum was declared to be present.

#### Agenda Approval

Marti Whitmore moved to approve the agenda as presented. John McClow seconded, and the motion passed unanimously.

Austin Keiser stated at 4:00 the meeting would be paused for comments from the new IBCC Director, Dan Gibbs.

# **Election of Officers**

Austin Keiser requested nominations for Chairperson. Marti Whitmore nominated Kathleen Curry to continue as Chairperson. Kathleen declined, saying she would like to step down. Kathleen Curry nominated Steve Anderson as Chairperson. John McClow moved nominations cease and to elect Steve Anderson by acclimation. Mark Roeber seconded and the motion carried. Steve Anderson took over the meeting Steve Anderson requested nominations for Vice-Chairperson. John McClow nominated and moved to elect Austin Keiser as Vice-Chairperson. Mark Roeber seconded and the motion carried unanimously. Austin Keiser remains the Vice-Chairperson.

Nominations were requested for Recorder. Kathleen Curry nominated and moved to elect Mike Berry as Recorder. Steve Fletcher seconded and the motion carried unanimously. Mike Berry remains the Recorder.

#### Approval of Minutes from the September 20, 2021 Meeting

Wendell Koontz requested a correction to the minutes to show he was present at the meeting.

Steve Fletcher moved to approve the minutes of the September 20, 2021 meeting as amended. Wendell Koontz seconded and the motion passed unanimously.

#### **Gunnison Basin Forest Health Planning Update**

Sonja Chavez gave an update on the Upper Gunnison Basin Watershed and Forest Health Zones of Concern Planning Study. Brad Piehl with JW Associates gave a presentation on Upper Gunnison Watershed Wildfire Assessment and discussed the work he is doing for the district in identifying fire zones of concern and other watershed health concerns. Matt McCombs with the USDA highlighted specific sections of the district's plan and discussed how the work done by the Upper Gunnison and Brad Piehl will incorporate into the plan. The comment period is extended to November 26.

# **Comments from New IBCC Director, Dan Gibbs**

Dan Gibbs, Executive Director of Colorado Department of Natural Resources, introduced himself as well as Kelly Romero-Healy, the Assistant Director on Water. Dan was recently appointed by Governor Polis as the Chairperson for the IBCC. Dan is from Gunnison, and a former Summit County commissioner. He has ample experience with forest health issues in Colorado.

#### **CWCB Update and WSRF Funding Proposal (Steve Anderson, Russ Sands)**

Russ Sands discussed the changes proposed in the WSRF Funding Proposal. There is a concern the lack of severance tax will leave no funding for roundtables in the near and far-term, so this is a plan to stabilize the water supply reserve fund (WSRF) for roundtables. The plan will turn the statewide account into a savings account to fund basins for 3 years. The plan will provide \$300K per year and institute a basin cap of \$750K. It also adds almost four times more money for PEPO. If money becomes available the board could always re-evaluate. Water loan grants can help offset the loss of the statewide match.

Some Roundtable members mentioned frustration with prioritization of funding. The Roundtable discussed the memo from Tom Alvey regarding the funding proposal.

Marti Whitmore moved to submit Tom Alvey's memo as comments from the Gunnison Basin Roundtable. Joanne Fagan seconded and the motion passed unanimously.

### IBCC Report (Joanne Fagan, Mark Roeber, Cary Denison)

Joanne Fagan reported on the IBCC meeting. Director Gibbs and the funding package were covered. Other topics included:

- An update on the BIP: It has focused on getting uniform quality of data. They are waiting for all public comment before being finalized.
- The Water Plan has a 90-day comment period (June 30-September 30).
- PEPO will be conducting a water awareness survey. The survey is available in English and Spanish. The purpose is to find out what people know about critical water issues.
- CWCB and the water education group are preparing a public awareness campaign on big river questions.
- There was a presentation on the first year's results from the Upper Colorado transfer project.
- There was a presentation on river hydrology. It is being predicted next year will be about 77% of average.
- They spent a lot of time talking about equity and demand management.

Next year the IBCC will be meeting in February, June, and October.

# **Education Committee Report (Raquel Flinker)**

Raquel Flinker reported they are still looking for a chairperson for this committee. They have reached out to Cindy McKee to see if she has an interested updating the website, and potentially in being the chairperson of the Education Committee. She would charge for this service. Cindy is putting together a proposal. Raquel and Sonja Chavez are willing to direct Cindy if she has questions.

# <u>Airborne Snow Observatory Water Plan Grant Letter of Support Request (Taylor Winchell)</u>

Taylor Winchell, representing the Colorado Airborne Snow Observatory work group (CASO), gave a presentation on their water plan grant request for Phase 1 of the Colorado Aerial Snowpack Measurement Study. The primary goal will be to expand airborne lidar flight coverage in Colorado. They are requesting a letter of support from the Gunnison Basin Roundtable.

Bruce Bair moved to support the Airborne snow Observatory with a letter of support for their water plan grant request. Justin Blair seconded and the motion carried unanimously.

# Grant Review Committee Report (Adam Turner)

Adam Turner introduced these items:

### Town of Olathe, Water Meter Replacement Project

The project is to replace water meters that are mostly 30+ years old. The project includes updates to meter reading hardware and software and billing software. The Town will also provide in-kind services in the form of project inspection and project management as well as in-kind work in replacing meters.

Neal Schwieterman moved to approve the request from the Town of Olathe for \$25,000 from basin funds and \$175,000 from statewide funds and to provide a letter of support for the water plan portion to replace water meters. Bill Nesbit seconded. Joanne Fagan and Jim Plumoff recused. The motion passed.

#### Orchard City Irrigation District, Dam Outlet Improvement Project

The Dam Outlet Improvement Project will modernize an irrigation dam and reservoir that have been used continuously since 1937. It seeks to improve the outlet control system to provide for an increase in flow monitoring and accuracy via upgraded electric controls for new guard and regulating gates and installation of electrical components for Supervisory Control and Data Acquisition (SCADA) control to be installed later. The motor operated regulating valve will make it possible to decrease spills and over-deliveries to irrigators.

Austin Keiser moved to approve the request for \$50,000 from basin funds and \$100,000 from state funds for the Orchard City Irrigation District, Dam Outlet Improvement Project. Jim Plumoff seconded and the motion passed unanimously.

#### Stewart Ditch Diversion Improvement

Building on studies and engineering from CWCB grants and North Fork Water Conservancy /Western Slope Conservation Center Stream Management Plan, this project would construct a new diversion and headgate for the Stewart Ditch diverting water from the North Fork of the Gunnison, near Paonia. This project is BIP listed. The new design would replace a push up dam in the river with a more permanent structure as well as reconstructing the existing headgate to provide better diversion control, screening, and overtopping prevention. The grantee, Trout Unlimited has procured or is pursuing grants from numerous sources, including an approved grant from the River District, Fish and Wildlife funding, CO Dept of Ag grant and others for a total match of \$465,000 and a total project cost of \$815,000. The ask from WSRF is for \$40,000 Basin funds and \$100,000 state funds. This project would serve as a model for other diversions from the North Fork, remove a recreational boating hazard and improve aging infrastructure to preserve agricultural water use.

Wendell Koontz moved to approve \$40,000 from basin funds and \$100,000 from state funds for the Stuart Ditch Improvement Project. Bruce Bair seconded and the motion passed unanimously.

### Center for Snow and Avalanche Studies, Support to Monitor Dust on Snow

This application from the Center for Snow and Avalanche Studies asks for \$15,000 from all 9 Roundtables and \$120,000 from the state (\$225,000) as part of a \$430,500 program to monitor dust on snow, including data collection, analysis and near real time access to data. It builds on previous studies which have highlighted the effects of dust on snow and provided useful information to water managers in this area for predicting runoff. The grant would provide three years of operation. The CSAS is a leader in snow monitoring data and is located in our backyard in Silverton. Data collection and snow monitoring are BIP listed.

Mike Berry moved to approve \$15,000 from basin funds and \$120,000 from statewide funds for the Center for Snow and Avalanche Studies to monitor dust on snow. Justin Blair seconded and the motion passed unanimously.

#### **Public Comment**

None.

#### **Other Business**

Sonja Chavez mentioned there was a proposal to mitigate wetlands in the Upper Gunnison on the headwaters of the Tomichi River at the bottom of Monarch Pass which could cause damage to water users on that stream. This will cause agricultural users to be expelled and leases to be cancelled.

#### **Future Meetings**

The next regular Roundtable meeting is January 17, 2022.
