APPLICATION FOR PARTY STATUS OF WESTERN RESOURCE ADVOCATES, TROUT UNLIMITED, CONSERVATION COLORADO, AND THE NATIONAL AUDUBON SOCIETY

Western Resource Advocates, Conservation Colorado, Trout Unlimited and the National Audubon Society (collectively, "WRA et al") hereby jointly submit this Application for Party Status to participate in the Colorado Water Conservation Board's ("CWCB") rulemaking hearing ("Rulemaking") concerning amendments to the Board's Rules Concerning the Colorado Instream Flow and Natural Lake Level Program, 2 CCR 408-2 ("ISF Rules").

I. Introduction and Statement of Position

Senate Bill 24-197 was passed in the 2024 session of the Colorado General Assembly to amend section 37-83-105, C.R.S., which governs temporary loans of water for instream flow purposes, by allowing temporary loans of stored water to the CWCB for use in stream reaches where the CWCB does not hold a decreed in-stream flow ("ISF") water right. Senate Bill 24-197 also directs the CWCB Board to promulgate rules to implement certain provisions of the bill, as needed.

WRA et al support CWCB Staff's proposed amendments to the ISF Rules because such amendments appropriately implement the provisions of Senate Bill 24-197, consistent with the intent of the General Assembly, by offering the CWCB greater flexibility to make use of voluntary water loans of storage rights for instream flow purposes, thus enhancing river protection and restoration opportunities while protecting Colorado's existing water rights holders.

WRA et al reserve the right to oppose additional amendments to the ISF Rules that may be proposed as part of this Rulemaking insofar as such amendments are unnecessary, were not properly noticed, or are inconsistent with the intent of the General Assembly in enacting Senate Bill 24-197.
