Description

This grant will be used to update Hudson's 2021 Water Efficiency Plan. Town Council and staff understand the needs and benefits of implementing long-term water efficiency activities. The plan update will include profiling and projecting the needs of Hudson's water supply system and users, a structured process for evaluating and selecting water efficiency activities for implementation, a public review process, and an implementation and monitoring plan to ensure long-term success.

In 2024, the Town's customers utilized approximately 275 (AF) of water. The Town of Hudson is expected to increase its annual water demand through new growth to approximately 357.5 AF of treated water (not including

Non-Revenue water) over the planning period. Water savings from this water conservation planning effort is estimated to save a total of 35.75 AF by 2034. The Town intends to build on the progress made with the 2021 plan with updated data on water usage and water conservation activities to generate these savings.

Water Project Justification

Updating the Town of Hudson’s WEP supports the goals outlined in Colorado’s Water Plan, the South Platte Basin Implementation Plan and the Statewide Water Education Action Plan. A WEP update directly ties in to supporting vibrant communities as outlined in the Colorado Water Plan. An updated WEP helps the Town by “... identifying targets for achieving savings through programmatic efforts, controlling system water loss, integrating with land use planning, and incentivizing sustainable water consumption,” which are all focal points in a water conservation plan (p.182).

An updated WEP also supports the South Platte Basin Implementation Plan goal to maintain and promote municipal and industrial conservation and efficiency, specifically Strategy 3.C “Encourage innovation and efficiency improvements”. By updating the WEP, Hudson can formally develop efficiency goals based on the latest data and projections, analyze the cost and benefit of efficiency improvements, and gather input from their water users.

The Town of Hudson’s WEP update would incorporate components of Outcomes 5 and 7 of the Statewide Water Education Action Plan. The WEP update supports Outcome 5 by encouraging the Town’s water users to provide input on the plan and engage with Town staff and Council. The WEP update also supports Outcome 7 by outlining behavior-driven water conservation activities for consideration and implementation.
