WESTERN COLORADO 2015

This report updates basic data concerning the depth to and elevation of groundwater in three distinct regions of western Colorado plus North Park. Most of the wells for which data are reported were originally constructed or identified in the 1970's by the United States Geological Survey (USGS) as a part of their statewide monitoring well network. The USGS monitoring effort was abandoned in 1982, and in 1991 the State of Colorado Division of Water Resources initiated a program to monitor water levels in about 50 wells of that former monitoring network. The number of monitored wells is sparse in some areas.

The wells listed in this report are part of a statewide water-level monitoring network funded by Senate Bill 200 (1987 Legislative Session). That legislation directed that a portion of the fees collected for applications for water well permits be used for the establishment of a program to monitor groundwater levels throughout the state.

Geologic/geographic areas covered in this report include:

- San Juan basin – two wells
- The Colorado Plateau and Grand Mesa – eight wells
- The Piceance basin – thirty-eight wells
- North Park – eighteen wells

All available water-level data for each well is plotted as a true time series. As in previous reports, the accompanying data table only lists data from the last 10 years. The report also contains data from wells, which are part of this monitoring effort, but for which measurements were not available in 2014. Wells lacking measurements in the past 10 years have been removed from the monitoring program and are no longer included in this publication.

The report is organized by geologic/geographic areas. The data for each area are preceded by a monitoring well location map that shows well locations and names. The aquifers in which these wells are completed include: alluvium, the Fruitland, Mesa Verde, Wasatch, North Park, Coalmont, San Jose, Dakota/Burro Canyon, Green River, Uinta and Parachute Creek members or formations. The specific aquifer being monitored in a well is listed on the data sheet for that well.
