Water District 30-A (Animas River)

The drainage basin of Junction Creek at and upstream of the ANIMAS CITY DITCH point of diversion, WDID 3000505, on Junction Creek located approximately 2 miles upstream of the confluence with the Animas River in the NE 1/4 NE 1/4, Section 18, Township 35N, Range 9W, NMPM; GPS location: UTMx 244269.0, UTM_y 4132754.7 NAD83

The drainage basin of Basin Creek at and upstream of the HARBAUGH DITCH point of diversion, WDID 3001119, on Basin Creek located approximately 2 1/2 miles upstream of confluence with the Animas River in the NE 1/4 NE 1/4, Section 12U, Township 34N, Range 10W, NMPM; GPS location: UTMx 244652.0, UTM_y 4121964.0 NAD83

The drainage basin of Little Cascade Creek at and upstream of the ASPASS LAKE DAM (a non-decreed structure) on Little Cascade Creek located approximately 1 1/2 miles upstream of the confluence with the Animas River in the SE/4 NE/4, Section 1, Township 38N, Range 9W, NMPM; GPS location: UTMx 252763.0, UTM_y 4164201.0 NAD83

The drainage basin of Cascade Creek at and upstream of the CASCADE CANAL point of diversion, WDID 3000523, on Cascade Creek located approximately 6 1/2 miles upstream of the confluence with the Animas River in the NE 1/4 NE 1/4, Section 11, Township 35N, Range 9W, NMPM; GPS location: UTMx 251061.0, UTM_y 4172629.0 NAD83

The drainage basin of Spring Creek and upstream of the MACY DITCH point of diversion, WDID 3000593, on Spring Creek located approximately 1 mile upstream of the confluence with the Animas River in the SE 1/4 SE 1/4, Section 10, Township 35N, Range 9W, NMPM; GPS location: UTMx 248761.0, UTM_y 4132783.0 NAD83

Water District 30-F (Florida River)

The drainage basin of the Florida River at and upstream of the BANKS-TYNER DITCH point of diversion, WDID 3001033, on the Florida River located approximately 24 1/2 miles upstream of the confluence with the Animas River, in the NW 1/4 SE 1/4, Section 16, Township 34N, Range 8W, NMPM; GPS location: UTMx 255982.1, UTM y 4122980.6 NAD83; as well as an additional area adjacent to and southwest of this drainage basin still within the Florida River Basin that generally includes a portion of Section 36, Township 35N, Range 9W; Section 31, Township 35N, Range 8W; a portion of the NE 1/4 Section 36, Township 34½N, Range 9W; and Section 5, Section 6, the N 1/2 Section 7, the N 1/2 and portions of the S 1/2 Section 8, and a portion of the W 1/2 SW 1/4, Section 9, Township 34N, Range 8W; all in the NMPM.

Water District 31 (Los Piños River)

The drainage basin of Beaver Creek at and upstream of the CITIZENS IRRIGATION CANAL point of diversion, WDID 3100569, on Beaver Creek located approximately 20 miles upstream of the confluence with the Los Piños River in the SE 1/4 NW 1/4, Section 24, Township 35N, Range 6W, NMPM; GPS location: UTMx 280248.0, UTM y 4130178.0 NAD83

The drainage basin of the Los Piños River at and upstream of the SPRING CREEK DITCH point of diversion, WDID 3101045, on the Los Piños River located approximately 16 3/4 miles upstream of the New Mexico border in the NE 1/4 SE 1/4, Section 15U, Township 34N, Range 7W, NMPM; GPS location: UTMx 270315.3, UTM y 4119147.4 NAD83

The drainage basin of Wallace Gulch at and upstream of the COLORADO SW DITCH NO 1 point of diversion, WDID 3100708, on Wallace Gulch located approximately 2 3/4 miles upstream of the confluence with the Los Piños River in the NE 1/4 NW 1/4, Section 33, Township 35N, Range 7W, NMPM; GPS location: UTMx 265380.0, UTM y 4127428.0 NAD83

Water District 32 (McElmo Creek)

The drainage basin of McElmo Creek at and upstream of the COTTONWOOD DITCH NO 2 point of diversion, WDID 3200529, on McElmo Creek located approximately 8 miles upstream of the Utah border in the NW 1/4 NW 1/4, Section 6, Township 35N, Range 18W, NMPM; GPS location: UTMx 150785.8, UTM y 4138395.0 NAD83

Water District 33 (La Plata River)

Water District 34 (Mancos Creek)

The drainage basin of the Mancos River at and upstream of the HENRY BOLEN DITCH point of diversion, WDID 3400534, on the Mancos River located approximately 76 miles upstream of the confluence with the San Juan River in the NW 1/4 SE 1/4, Section 31, Township 36N, Range 13W, NMPM; GPS location: UTMx 205457.0, UTM y 4136976.0 NAD83

Water District 71 (Dolores River)

Water District 77 (Navajo River)

The drainage basin of the Little Navajo River at and upstream of the BRAMWELL IRRIGATION DITCH point of diversion, WDID 7700509, on the Little Navajo River located approximately 1/3 mile upstream of the confluence with the Navajo River in the NE 1/4 SE 1/4, Section 4, Township 32N, Range 1E, NMPM; GPS location: UTMx 336025.8 UTM_y 4100700.1 NAD83

Water District 78 (Piedra River)

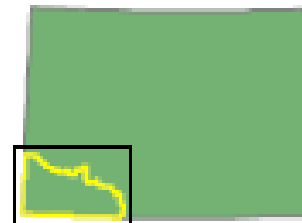

The drainage basin of Stollsteimer Creek at and upstream of the DYKE NO 1 DITCH point of diversion, WDID 7800539, on Stollsteimer Creek located approximately 17 1/2 miles upstream of the confluence with the Piedra River in the SW 1/4 NW 1/4, Section 11, Township 34N, Range 3W, NMPM; GPS location: UTMx 306587.1, UTM_y 4122856.8 NAD83

The drainage basin of Devil Creek at and upstream of the FORD DITCH point of diversion, WDID 7800546, on Devil Creek located approximately 7 miles upstream of the confluence with the Piedra River in the NE 1/4 SE 1/4, Section 12, Township 34N, Range 4W, NMPM; GPS location: UTMx 299626.0, UTM_y 4122455.0 NAD83
