WESTERN COLORADO WATER LEVEL MEASUREMENTS 2019

This report updates basic data concerning the depth to and elevation of groundwater in three distinct regions of western Colorado. Most of the wells for which data are reported were originally constructed or identified in the 1970's by the United States Geological Survey (USGS) as a part of their statewide monitoring well network. The USGS monitoring effort was abandoned in 1982, and in 1991 the State of Colorado Division of Water Resources initiated a program to monitor water levels in about 55 wells of that former monitoring network. The number of monitored wells is sparse in some areas.

The wells listed in this report are part of a statewide water-level monitoring network funded by Senate Bill 200 (1987 Legislative Session). That legislation directed that a portion of the fees collected for applications for water well permits be used for the establishment of a program to monitor groundwater levels throughout the state.

Geographic areas covered in this report include:

- San Juan basin - three wells
 - Fruitland and San Jose Formations
- The Colorado Plateau and Grand Mesa - eleven wells
 - Mesa Verde Group, Dakota/Burro Canyon Formations
- The Piceance basin - thirty-six wells
 - Green River, Parachute Creek, and Uinta Formations
- Garfield and Mesa Counties - eight wells
 - Wasatch Formation

The monitored wells are not evenly distributed in western Colorado, but are focused in specific basins or areas of interest. The well data are ordered alphabetically by well name. Maps for each of the four areas, displaying monitoring well locations and names, precede the data for individual wells. The specific aquifer being monitored in a well is listed on the data sheet for that well.

All available water-level data for each well is plotted as a true time series. As in previous reports, the accompanying data table only lists data from the last 10 years. The report also contains data from wells, which are part of this monitoring effort, but for which measurements were not available in 2019. Wells lacking measurements in the past 10 years have been removed from the monitoring program and are no longer included in this publication.
